To help the government fight the funding of terrorism and money laundering activities, Federal law requires all financial institutions to obtain, verify, and record information identifying each person opening an account. What this means to you: This information sheet must be filled out completely in order to verify your information and open your account. We must be able to identify the person (student) requesting the account. We must have the deposit required to open an account. If you are joining the credit union and opening a savings account, the minimum deposit is \$5. Once your account is opened, the credit union will send you all federally required disclosures.
